Administrative Note

Holy Name Congregation was founded in 1884. Labor for the original church was donated by many of the parishioners who were artisans in various trades. The two rooms on the first floor were used for classrooms while services were held on the second floor. A new church was built and dedicated in 1914. A new school building opened in 1956. The school was staffed by Dominican Sisters. Holy Name Church merged with St. Rose of Lima, St. Casimir, Holy Trinity, and St. Stanislaus to form St. Richard Congregation on July 1, 1998.

Scope and Content *a brief description of the types of materials in the collection.*

The collection contains parish records of a Roman Catholic Church on the south side of Racine. Parish records include parish meeting minutes, bulletins, envelope receipt logs, parish censuses and family registers, parish council records, as well as parish organization records such as the Holy Name Society, the Christian Mothers' Society, the Confraternity of Our Mother of Perpetual Help, the Mission Society, the Rosary Confraternity, the Holy Name Sewing Circle, St. Michael's Auxiliary, and the Blessed Young Ladies Sodality. The collection also contains various financial records from the parish including annual financial statements, finance committee records, general ledgers, insurance records, receipt and expense logs, a value appraisal, and other miscellaneous financial records.
